### **Get to Know Your Professor**

My name is Bernard Lewis. I teach primarily English and Humanities. My undergraduate degrees are in English and Music from the University of NC-Charlotte. My MA is in English Studies from Murray State University in KY. I am also a Graduate Gemologist from the Gemological Institute of America (sort of a PhD in that field). Previously, I led Study Abroad programs in London and Italy. I've traveled around much of Britain and spent time in Edinburgh. Since this will not be my first time there, I'm comfortable getting us around. Our texts will include not only the readings but also art, music, architecture, and the cities themselves. Classes will meet at breakfast, in museums and galleries, in restaurants and pubs, on the sidewalks and on the Tube. I have taught "Fantasy, Myth & Legend" in the classroom several times, and I'm excited to take it to London and Edinburgh! My first time abroad was life-changing, and I look forward to sharing that experience with you.

## **Course Description**

Expand your worldview while discovering masterpieces of "Fantasy, Myth, and Legend" in two of the world's most iconic cities: London and Edinburgh. Explore the social and historical contexts of literary classics such as *Beowulf, Dracula, Frankenstein, Dr. Jekyll and Mr. Hyde*, and *Harry Potter*. Deepen your appreciation of great artists' depictions of myths and legends in the British Library and galleries of great museums – the British Museum and the Scottish National Gallery. Check out the darker side of British culture on a Jack the Ripper tour, in the Tower of London's dungeons, and on a ghost walk in Edinburgh. Experience one of Shakespeare's tragedies at the Globe Theatre.

## **Student Learning Outcomes**

Upon completion of all coursework with a passing grade and full participation in course activities, students shall be able to:

- 1. understand the meaning of the terms fantasy, myth, and legend as they apply to this program.
- 2. connect literary, artistic, and musical works of fantasy, myth, and legend to their creators and sites visited in London, Edinburgh, and other locations.
- 3. record their personal discoveries during course-related site visits in hand-written journals.
- 4. connect texts literature, music, artwork, architecture, museum artifacts and their contexts to site visits.
- **5.** gain an understanding of British and Scottish culture through not only their textual studies but also their interactions with the local people and their surroundings.
